The units should not be exposed to untreated fresh air sources / high humidity for excessive duration whilst operating. This must remain within Mitsubishi Electric design limits. Due to the modification process if the above is not followed, it is possible for excessive condensation to form within the unit which could lead to damage to electrical components. Alpollo Air take no liability for any units which are damaged due to poor installation design which results in condensation damage.
